Completely bootstrapped by its founders, the platform has processed tens of thousands of invoices, helping businesses save 15-20 hours monthly on administrative tasks while achieving 40% faster invoice processing and 60% improved payment collection timelines. ## COMPANY HISTORY & TIMELINE

### The Genesis Story (2019)

The idea for Afri Invoice was born in 2019 when founder Mark Odenore, a British-Nigerian entrepreneur who started his first business in Nigeria at a young age before moving to the UK, witnessed talented African entrepreneurs struggling with invoicing tools built for Silicon Valley, not Lagos or Dakar. After months of market research and interviewing hundreds of small business owners who shared the same pain points, Odenore identified a clear gap in the market.

### The Problem We Identified

African businesses were forced to choose between expensive, overcomplicated solutions like QuickBooks that ignored local payment methods and tax requirements, or basic tools that couldn't handle the complexity of modern African commerce. Trying to integrate MTN Mobile Money with Zoho or explaining Rwandan tax compliance to Wave's support team highlighted that these platforms, while working well in their home markets, left African businesses patching together incomplete solutions.

### June 2024: Official Launch

After years of research and development, Afri Invoice was officially launched in June 2024. The company was:

- **Fully Bootstrapped:** Built entirely by founders without external funding
- **Built from Scratch:** Developed a fully functional MVP from the ground up
- **Community-First:** Cultivated an engaged pre-launch community of African entrepreneurs
- **Compliance-Ready:** Proactively worked with regulators like Nigeria's NDPC to ensure compliance
- **Infrastructure-Ready:** Built scalable infrastructure ready to support rapid expansion

**Market Validation:** The response was overwhelming for a pre-launch product. Word-of-mouth referrals drove steady growth in the waiting list, with entrepreneurs actively sharing the mission within their networks. Early testers provided invaluable feedback that shaped the final product.

### July 2025: Major Media Coverage

Afri Invoice gained significant media attention as the NRS (FIRS) e-invoicing mandate approached. Major publications including Legit.ng, Disrupt Africa, The Guardian Nigeria, TheCable, and Independent Nigeria covered the company's solutions for Nigerian businesses navigating the new regulatory landscape.
